CMS 2744 Annual Facility Survey is due March 31st!!

Every dialysis and kidney transplant facility in the country is required to submit annual patient census data, treatment, and staffing totals via the CMS 2744 in EQRS. Please note, **some** dialysis organizations are submitting CMS 2744 forms at the corporate level, and you may not need to complete the CMS 2744 at the facility level. **If you are unsure about your organization's CMS 2744 submission plan or if you have questions, please reach Aletha at (651) 644-5839 for Michigan facilities or Alli at (651) 644-2911 for MN, ND, SD, WI facilities.**

5 Data Quality Manager Tips

Tip #1

- If you expect to see a CMS 2728 for a new patient on your EQRS Dashboard but the CMS 2728 is missing, please search for the patient in EQRS to ensure they are admitted to your facility.
- If the patient is not admitted to your facility in EQRS, please reach out to us at the Network for your next steps
 - o If you work for a batch submitting organization (such as DaVita, Fresenius, Sanford, etc.) and a patient or a CMS 2728 is missing in EQRS for more than one week following their start date at your facility please connect with us ASAP.

 Batch should be occurring at least weekly and should bring over the patient from your EMR to EQRS automatically.

Tip #2

- If you are getting pink error messages when trying to complete a CMS 2728, please do not hesitate to reach out to us as soon as you're able.
- If you are getting yellow warning messages when trying to complete a CMS 2728, you simply need to verify that the data is correct on the 2728 and click the small checkbox above the CMS 2728 to move forward.

Tip #3

- Blue ink nephrologist and patient signatures are no longer needed on 2728 forms.
- For all 2728 forms, you can and should be faxing 2728s to the patient's nephrologist as soon as possible you do not need to wait until the nephrologist's rounding day once a month.
 - 1. Fax the 2728 to the nephrologist for their review and signature.
 - 2. Receive the 2728 back via fax from the nephrologist.
 - Submit the signature date on the 2728 in EQRS.
 - 4. Send a copy of the signed 2728 to Social Security Administration/Medicare, if applicable

Tip #4

- Please ensure you are using the correct differentiation for lab dates on 2728 forms: Prior lab values and Admission lab values.
 - o Prior lab values: use when labs are within 15-45 days prior to the ESRD start date
 - o Admission lab values: use when labs are within 15 days prior to the ESRD start date and including the actual start date


